By the referenced letter, SCE submitted to the NRC the final report on cultural resources affected by the San Onofre 230Kv transmission lines. Submittal of this report completed Section 4.2.1 ("Cultural Resources Data Recovery Program") of the San Onofre Nuclear Generating Station Units 2 and 3 Environmental Protection Plan. The Environmental Protection Plan is incorporated as Appendix B to Facility Operating License Nos. NPF-10 and NPF-15 for San Onofre Units 2 and 3, respectively. Subsequently, SCE received a request from the State Historic Preservation Officer (Enclosure A) to provide documentation of the curation arrangement for the cultural materials recovered during the Cultural Resources Data Recovery Program. Provided as Enclosure B to this letter is the documentation of the curation arrangement between SCE and California State University, Fullerton.

The Office of Historic Preservation (OHP) has reviewed the Research Proposal for a Cultural Resources Data Recovery Program for the 230kV Transmission Line Rights-of-Way From San Onofre Nuclear Generating Station To Black Star Canyon and Santiago Substation and to Encina and Mission Valley Substations, and the Cultural Resources Data Recovery Program for the 230kV Transmission Line Rights-of-Way From San Onofre Nuclear Generating Station To Black Star Canyon and Santiago Substation and to Encina and Mission Valley Substations, by Cultural Systems Research, Inc.


Based on the proposal and the final report, we concur that the project has had no adverse effect on National Register eligible properties. However, the report does not provide for the permanent curation of the cultural materials recovered during the project. OHP staff member Robert Jackson has discussed the curation problem with Southern California Edison representative Dr. David White, and we understand from this conversation that the collection, which is now in the possession of Southern California Edison, is planned for curation at California State University, Fullerton. such an arrangement is acceptable to the OHP and we would appreciate documentation of the curation arrangement for our files.

Based on the data recovery report and an arrangement for curation, the OHP concurs that the site will incur no adverse effects based on data recovery. Please forward the proposal and data recovery report to the Advisory Council on Historic Preservation, if you have not already done so. Once the Advisory has reviewed and made a no adverse effect determination, responsibility to consider the effects on important cultural resources on this federally licensed undertaking will be terminated, pursuant to Section 106 of the National Historic

Preservation Act of 1966, as amended.

The OHP appreciates your consideration of cultural resources, and looks forward to receiving a copy of the final curation agreement. If you have any questions please contact Mr. Robert Jackson of our staff, at (916) 322-9602.
