SUBJECT:	STAFF RESPONSE TO THE AUDIT OF U.S. NUCLEAR REGULATORY COMMISSION'S OVERSIGHT OF ACTIVE COMPONENT AGING (OIG-14-A-02)

Your report dated October 28, 2013, entitled "Audit of NRC's Oversight of Active Component Aging (OIG-14-A-02)," includes the staff's formal comments of the original draft audit. These formal comments were transmitted in a memorandum dated September 27, 2013, and are listed as Appendix B to OIG-14-A-02. You responded to these formal comments in Appendix C to OIG-14-A-02. The staff has reviewed the audit report, including your responses to the staff's formal comments.

This audit report contains two recommendations that request additional actions by the staff in response to the findings of the audit.

Recommendation 1:

This recommendation states that the Executive Director for Operations (EDO) should:

Perform and document a thorough and systematic evaluation of the need for an NRC program to oversee the management of active component aging activities, all within the context of the current Reactor Oversight Program (ROP) environment. Evaluation elements are to include, but should be limited to, the need for:

- (a) program policies, goals, and objectives, and
- (b) program feedback and corrective actions for continual improvement.

The ROP provides a framework for ensuring that both active and passive aging issues with the potential to impact safety are addressed in a timely manner. This framework provides assurance that the U.S. Nuclear Regulatory Commission (NRC) will identify safety-significant,
