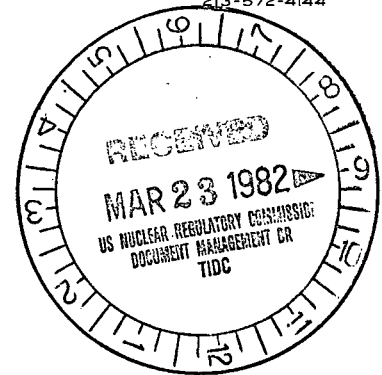

Enclosed are three executed and thirty-seven conformed copies of Amendment Application No. NPF-10-1 in Docket No. 50-361. Amendment Application No. NPF-10-1 consists of Proposed Change No. 1 to the Technical Specifications incorporated into Facility Operating License No. NPF-10 as Appendix A.

Proposed Change No. 1 to the Technical Specifications requests revision of specification 3.4.8.3.1.a. The proposed change is requested to clarify the Code requirements for the Shutdown Cooling System Relief Valve consistent with existing clarification for the Pressurizer Safety Valves. No physical changes are required to the plant.

The proposed change for specification 3.4.8.3.1.a was discussed with NRC staff members on March 12, 1982 and was submitted by letter dated March 12 from Mr. David F. Pilmer to Mr. Frank Miraglia. NRC approval was granted verbally on March 13, 1982. Approval of this change was required to facilitate initial entrance into Operational Mode 5.

It is respectfully requested that Amendment Application No. NPF-10-1 be reviewed promptly and appropriate action taken. Direct distribution of Application No. NPF-10-1 to the Facility Operating License No. NPF-10 will be made in accordance with the service list provided by SCE's letter of May 18, 1981 to the Commission. An affidavit attesting to the fact that distribution has been completed will be provided within ten days of amendment docketing.

Also enclosed is Southern California Edison Company's check in the amount of \$1,200.00 as required by 10 CFR 170.22.
