Enclosed are three executed and thirty-seven conformed copies of Amendment Application No. NPF-10-2 in Docket No. 50-361. Amendment Application No. NPF-10-2 consists of Proposed Change No. 6 to Facility Operating License No. NPF-10.

Proposed Change No. 6 is a request for revision of Technical Specification 4.8.4.1.a.2. The proposed change is a request to eliminate the Trip Setpoint (amperes) and Response Time (sec) requirements from Table 3.8-1, Containment Penetration Conductor Overcurrent Protective Devices. The proposed change has no effect on the manner in which the protective devices will be tested and no physical changes are required to the plant.

The proposed change for specification 4.8.4.1.a.2 was discussed with NRC staff members and was submitted by letter dated April 7, 1982 from Mr. K. P. Baskin to Mr. Frank Miraglia. NRC approval was granted verbally on April 9, 1982. Approval of this change was required to facilitate initial entrance into Operational Mode 4.

It is respectfully requested that Amendment Application No. NPF-10-2 be reviewed promptly and appropriate action taken. Direct distribution of Application No. NPF-10-2 to the Facility Operating License No. NPF-10 will be made in accordance with the service list provided by SCE's letter of March 30, 1982 to the Commission. An affidavit attesting to the fact that distribution has been completed will be provided within ten days of amendment docketing.

Also enclosed is Southern California Edison Company's check in the amount of \$1,200.00 as required by 10 CFR 170.22.
