Reference "B" enclosed the NRC safety evaluation supporting Amendment No. 8 to Facility Operating License NPF-10 for San Onofre Nuclear Generating Station, Unit 2 (SONGS 2). Amendment No. 8 changed the date for operability of the post-accident sampling system (PASS) and for implementation of the post-accident sampling program from "prior to exceeding five (5) percent power" to "January 1, 1983". Amendment No. 8 was responsive to Reference "C" which requested the NRC action because of a number of problems that collectively prevented Southern California Edison Company (SCE) from declaring the PASS operable.

Improvements and modifications, as discussed in Reference "C" and in a meeting with NRC staff on September 13, 1982, have been completed. Testing of each individual item has also been completed. On the day that the PASS Demonstration Test was to be performed, SONGS 2 tripped while operating at the fifty percent power level. The plant remains in a shutdown condition to replace reactor coolant pump seals. With the plant shutdown, it is not possible to complete the PASS Demonstration Test or to implement the enhanced operator training on the system after the demonstration test.

SONGS 2 is expected to return to power by early January, 1983 at which time the PASS Demonstration Test will be completed and operator training will be conducted. In the meantime SCE considers the PASS to be operable and License Condition 2.C(19)i to be satisfied.
