Upon review of Revision 5 of the U.S. EPR Tier 2, FSAR, Chapter 16, "Technical Specifications (TS)," the following item was developed to address proposed changes to the EPR TS and Bases without citing a source document which can be used to support these changes:

Page 3.5.5-1: A new Required Action D.2.2 is added to LCO 3.5.5, "Extra Borating System," without a discussion being added in the associated bases. Also this item is not listed in the Table of "Summary of Changes for Rev. 5," so the staff cannot tell what initiates the changes. The applicant is requested to provide a justification for these changes and revise the associated bases to include a discussion of Action D.2.2 accordingly.
