We appreciated the chance to talk with you and Mr. Paulson last week about San Onofre Nuclear Generating Station One (SONGS 1). We were able to obtain a copy of the January 20th letter from Mr. Eisenhut (NRC) to Mr. Baskin (SCE), regarding Southern California Edison's proposed Integrated Living Schedule. It was very helpful and became part of the administrative record in the OII 83-10-02 proceedings currently considering whether or not to remove SONGS 1 from the ratebase.

We have one further question. Have Southern California Edison and San Diego Gas & Electric committed themselves to each one of the counter proposals or modifications you made to the Integrated Living Schedule made in Mr. Denton's February 8, 1984 letter to Mr. Baskin? If so, was the commitment made orally or in writing? If orally, could you notify us when and by whom? If in writing, could you please send us a copy or at least the date, author and recipient of the letter?

We are very interested in the future of SONGS 1 and may contact you later with other questions. Thank you for your help.
