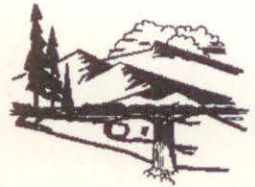

Dear Mr. Cash:

The Land Quality Division (LQD) of the Wyoming Department of Environmental Quality (WDEQ) is in receipt of Lost Creek ISR's (LCI) Notice of Completion of Construction for Class 3 wells in Mine Unit 1, Header House 4 (i.e. HH 1-4) at the Lost Creek ISR Project. The Notice was received at the Lander WDEQ/LQD office on October 17, 2013. LQD accepts LCI's certification of the proper construction of the 77 wells in HH 1-4 in compliance with the approved Operations Plan for Permit 788 and with LQD's Noncoal Rules and Regulations, Chapter 11, Section 11(b).

Please be advised that LQD will not exercise its right to inspect these wells as provided for in Chapter 11, Section 11(b)(ii)(A) and (B).

Lost Creek ISR is authorized to commence ISR injection and mining operations with the 77 specified wells within HH 1-4 in accordance with the Operations Plan for Permit 788.
