By letter dated October 12, 2012 (Agency-wide Documents Access and Management System (ADAMS) accession number ML12290A139), as supplemented February 14, 2013 (ML13050A326), the cask vendor and certificate of compliance (CoC) holder, EnergySolutions, submitted a request to the U.S. Nuclear Regulatory Commission (NRC) in accordance with Title 10 of the Code of Federal Regulations (10 CFR) 72.240 to renew CoC No. 1007. EnergySolutions' renewal request is for a term of 40-years. The renewal applies to the initial CoC and Amendment 1 through Amendment 6 for the VSC-24 Storage System.

To support this CoC renewal request, Energy Solutions submitted the final safety analysis report (FSAR) for the VSC-24 Ventilated Storage Cask System, Docket No. 72-1007, Revision 8, dated April 2009.
