The Revised Notice described two Severity Level IV violations resulting from an inspection conducted at your Detroit, Michigan, facility August 18-21, 2009. The Revised Notice required a written response for only Violation A. Your letter acknowledged Violation A and outlined the corrective steps taken to address the concerns noted in the Revised Notice.
