LICENSEE:

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Nuclear Regulatory Commission (NRC) rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are as follows:

10 CFR 32.16(c)(1) requires the licensee to file a report for the transfer of items containing by-product material. The report is to be submitted on or before January 31 of each year for the period covering the preceding calendar year.

Contrary to the above, the licensee failed to file a report with the NRC which includes a description or identification of the type and quantity of each product transferred the radionuclide in each type of product and model number of units transferred, and the total quantity of each radionuclide transferred. Specifically, the licensee had not filed reports covering the period for calendar year 2012.

The licensee committed to filing the required report for calendar 2012 within 30 days of this inspection date. The licensee's corrective actions include determining the description or identification of the type and quantity of each product transferred the radionuclide and the total number of units transferred or distributed, compiling the required information, producing a report, and submitting that report; and committed to submit a report to the NRC every year as required.

I hereby state that, within 30 days, the actions described by me to the inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved).
