I think that for the QA topic, we should discuss with them the idea that we are contemplating to have a public meeting instead of the visit. We can tell them that what we are looking for is their explanation on how they are meeting the requirement of 52.79(a)(25), which requires the applicant to provide a QA program consistent with AppB to 10 CFR Part 50 for design, fabrication and construction activities. Although we understand that the FSAR is not a quality document, all design activities performed in support of the FSAR (e.g., siting, geotechnical, departures from the DCD) are quality activities subject to AppB requirements. At this time, the application is not providing an applicant's QA program for these activities as required by 52.79(a)(25).
