Reactor Licensing Action Estimates
San Onofre Nuclear Generating Station, Units 1, 2, and 3

Gentlemen:

As requested in NRC Administrative Letter 99-02, this letter provides estimates of the number of licensing actions Southern California Edison (SCE) expects to submit for San Onofre Units 1, 2, and 3 in fiscal years 2000 and 2001.

For San Onofre Unit 1, SCE has identified approximately 3 licensing actions, as defined in Administrative Letter 99-02, in fiscal year 2000 and approximately the same number of licensing actions in fiscal year (FY) 2001. Included in these submittals will be at least one submittal expected to generate a complex review - the application for an Independent Spent Fuel Storage Installation on or before FY 2001.

For San Onofre Units 2 and 3, SCE expects to submit about 20 licensing actions in fiscal year 2000 and about 20 licensing actions in fiscal year 2001. Included in these submittals will be at least one submittal expected to generate a complex review anticipated in early FY 2000, such as fuel consolidation. Additionally, during this time frame, SCE anticipates submitting approximately 15 precedent setting risk-informed licensing actions. Another submittal of note in the first quarter of FY 2000 will be an application for construction period recapture.
