Doel-3/Tihange 2 Rx Vessel Indications – NRR/DE staff (Carolyn Fairbanks, Jeff Poehler, and Bob Hardies) are continuing to follow the analysis and testing being performed by the Belgians to support a decision on future operation of Doel 3 and Tihange 2. A public meeting is scheduled for January 8 to share information with the industry. NRR/DE staff will consider the final safety determination results by the Belgian authorities, expected by the end of 2012, when deciding on future actions for domestic plants such as enhanced inspections. NRR/DE staff also participated in a meeting in conjunction with RES at NRC headquarters November 15-16 with the chairman of the Belgian regulatory working group on structural integrity of the affected vessels. In addition, the staff is following and will review efforts led by the industry to address this issue including a survey of US plants fabrication history related to reactor vessel forgings and a probabilistic fracture mechanics analysis using the FAVOR code.




