Dear FOIA officer:

Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, I request copies of certain records relating to the Parks Shallow Land Disposal Area ("SLDA") in Parks Township, PA. Specifically, I request copies of all documents, including electronic documents, in the possession of the Nuclear Regulatory Commission or its agents or contractors (collectively "NRC"), created, edited, or otherwise modified on or after August 1, 2011, relating whole or in part to conditions, remediation activity, or contracting at the SLDA.

My request includes, but is in no way limited to, information relating to any of the following: Unexpected conditions encountered, suspected, or at one time suspected, during remediation-related activity; the decision to suspend cleanup efforts in September 2011; mishandling of any materials, violation of any requirements or guidance, or deviation from plans by contractors or others; any changes that have occurred in remediation plans since the August 2011 commencement of remediation efforts, including but not limited to changes in schedule, scope, and estimated costs of the remediation, and the basis for any such changes; termination of any contract with Cabrera Services, Inc.; amendment or other modification of, or deviation from, the Record of Decision; groundwater monitoring; any memorandum of understanding involving the U.S. Army Corps of Engineers, the NRC, or the Department of Energy; the materials handling plan; and NRC project management, technical review, inspections, or other activity.

Please conduct a comprehensive and thorough search of records and make available all responsive documents. If you determine that any records or portions of records responsive to this request are exempt from disclosure, please provide an itemized list of withheld information


