In a memorandum from E.G. Case to E. Volgenau, dated April 5, 1978, NRR requested IE to make an inquiry into whether safety information had been withheld from the regulatory staff regarding steam generator tube support plate cracking at San Onofre Unit 1. The results of the inquiry by a special team of IE inspectors were summarized in a report which was officially transmitted to NRR by the attached memorandum from V. Stello, Jr. to H.R. Denton, dated May 20, 1980. This report is being sent to the Project Manager, Tom Wambach, and will be kept in his San Onofre file.

Based on the results of inquiry the special team has concluded that they were unable to unequivocally establish that the licensee did intentionally withhold safety information from the regulatory staff. Therefore, they see no need for further action and have closed the inquiry.

Your office requested that IE make an inquiry into whether safety information had been withheld from the regulatory staff regarding steam generator tube support plate cracking at Southern California Edison's San Onofre Unit 1. This request was contained in a memorandum from E. G. Case to E. Volgenau dated April 5, 1978.

A special team of IE inspectors performed the requested inquiry which included: interviews of NRC, Westinghouse, EDS, and Southern California Edison personnel and collection and review of pertinent photographs and documents. The report of the results of the inquiry made by the team is enclosed.

Based on their review of the results of the inquiry the team was unable to establish that the licensee did intentionally withhold safety information from the regulatory staff. Further, the team was unable to establish that the regulatory staff did ask the licensee whether the San Onofre Unit 1 steam generators had experienced flow slot cracking similar to that experienced elsewhere.

As a result of the investigation findings, we had considered the issuance of a Notice of Violation to the licensee. We find, however, that the investigation report does not clearly establish noncompliance. We see no need for further action at this time and have closed the inquiry.
