A meeting was held in Bethesda, Maryland on March 26, 1987, with representatives of the licensee and Combustion Engineering. The purpose of the meeting was to discuss the next phase of the CE Owner's Group's CPC Improvement Program and how it will be implemented at San Onofre. Enclosure 1 lists the meetings attendees and the meeting is summarized as follows:

SUMMARY

The objective of the CPC Improvement Program is to eliminate unnecessary trips. SCE will submit proposed changes including the addition of a Control Element Assembly (CEA) Motion Inhibit, a CEA Withdrawl Prohibit, and the increase of 2 of the addressable software constants that specify certain delay times from 20 seconds to 1 hour or slightly more to allow time for appropriate actions to be taken before a trip signal is generated. These proposed short term changes will be submitted on the San Onofre docket in a 4 to 6 month time frame. The submittal will include evaluations of how the changes will affect any accident sequences, create the possibilities for an accident or malfunction of a different type than any evaluated previously or affect safety margins as defined in the technical specifications and will also include a basic probabilistic assessment as part of their justification. If the changes do not involve changes in the plant technical specifications, the NRC staff review will culminate in a safety evaluation rather than a license amendment. Long term improvements were discussed briefly and will be submitted separately sometime in the future. The long term changes are not applicable to SONGS 2 and 3, but are applicable to System 80 plants.
