SUBJECT: SUMMARY OF MEETING TO DISCUSS QUESTIONS REGARDING VARIOUS FIRE PROTECTION ISSUES

On April 16, 1987, representatives of the licensee and the NRC staff met in Bethesda, Maryland to discuss questions which have arisen in conjunction with the licensee's Appendix R reappraisal effort. A list of attendees at the meeting is enclosed.

The licensees stated that the Appendix R analysis is substantially complete. A docketed submittal which includes the compliance assessment report, request for approval of deviations and responses to the staff requests for additional information, will be transmitted to the staff no later than May 30, 1987. The staff expressed concern that, pending final resolution of outstanding fire protection issues, adequate interim compensatory measures should be implemented. The licensee committed to respond to this concern, in writing, by May 8, 1987.

A "sample" deviation request was discussed. The staff provided specific guidance as to the information which should be included in each request for approved deviation.

The adequacy of in-plant fire barrier penetration seals was discussed. The licensee indicated that a discussion of this issue would be provided in the response to the staff request for information on this item.

The licensee requested clarification regarding the physical independence of the alternate shutdown capability from the fire area under consideration. The staff responded that where cables or components of the alternate shutdown capability were located within the fire area, these systems would be considered to be physically independent of the normal shutdown system if they were separated/protected by the fire protection options of Section III.G.2 of Appendix R or by an equivalent level of protection that had been specifically approved by the staff.
