Dear Mr. Kazi:

This letter refers to the license termination request sent to us by Mr. John Ma on October 17, 2013, through email. In order to continue our review, we need the following additional information.

Title 10, Code of Federal Regulations, Chapter 32 (10 CFR 32), section 32.16 requires each person licensed under § 32.14 to maintain records of transfer of byproduct material and file a report with the Director of the Office of Federal and State Materials and Environmental Management Programs by an appropriate method listed in § 30.6(a), including in the address: ATTN: Document Control Desk/Exempt Distribution.

Section 32.16 requires licensees who permanently discontinue activities authorized by the license issued under § 32.14 to file a report for the current calendar year within 30 days after ceasing distribution. Section 32.16(d) states that If no transfers of byproduct material have been made under § 32.14 during the reporting period, the report must so indicate.
