Dear Mr. Lynch:

On October 24, 2013, the U. S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Joseph M. Farley Nuclear Plant, Units 1 and 2. The inspectors discussed the results of this inspection with you and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

This report documents one finding of very low security significance (i.e., Green as determined by the Physical Protection Significance Determination Process) that was identified during this inspection. The deficiency was corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection before the inspectors left the site. This finding was determined to not have an associated crosscutting aspect, in accordance with Inspection Manual Chapter (IMC) 0310.

The NRC is treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2 of the NRC Enforcement Policy because of the very low safety significance of the violation, and because it was entered into your corrective actions program. If you contest this NCV, you should provide a response within 30 days of the date of this inspection report, with the basis of your denial, to the Nuclear Regulatory Commission, Administrator, Region II; Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC Resident Inspector at the Farley Nuclear Plant.
