Dear Phil:

I mentioned in a previous conversation we were in the process of hiring a consultant, pending the filling of the vacancy of our staff technical expert who had been assigned the lead responsibility for the Annual Exercise scenario and data package.

Fortunately, that person is due on board May 31 and is expected to remain with us through the October 17 Exercise. His name is Ron Maisel and will be working directly with you on technical matters. On matters of policy, I will continue to be your point of contact. If you have a doubt or concern at any time, however, I will want you to call me directly to ensure our mutual understanding. In the final analysis, I am responsible for a successful Exercise.

In this context, our May 30 exercise meeting was abbreviated in anticipation of our consultant's arrival May 31. One of his first assignments will be to finalize the scope and objectives. He will also coordinate development of the basic scenario in advance of the next planning meeting on June 19 at 1:00 p.m., which was added to the planning schedule to ensure our preparedness for the initial and firm Simulator session on June 24.

As mentioned in my previous letter, we will be accommodating Gail's request for a 3-hour duration at the Site Area Emergency level and 2 hours at the General Emergency. Additionally, we are holding to an 0800 initiating event for an Alert, 0900 Site Area Emergency declaration, 1000 estimated arrival of the NRC Site Team, a General Emergency declaration at 1200, and termination around 1400.

I repeat that you are welcome to attend any or all of our meetings and, again, recommend you confirm any particular meeting date in advance.
