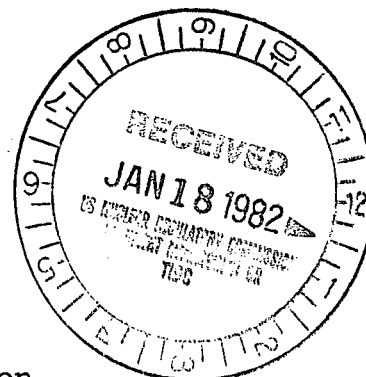

Items No. 1 and No. 2 were provided informally to the NRC on January 8, 1982 and Item No. 3 on January 13, 1982.


Regarding independent design calculations, GA is in the process of developing the basis for selecting features for such calculations and identifying those features. We will review those with you prior to the commencement of this task by GA. The results of the independent calculations will be included in the final report to the NRC on March 31, 1982.

In response to a question raised by NRC staff members, we would like to state once again that only the design bases included in the FSAR as amended to date will be the basis of the GA review.

Regarding the financial independence of GA, a letter has been requested of GA to clarify and confirm its financial independence. We will forward the letter to the NRC as soon as it is available.
