Units 2 and 3

In a letter to you dated December 22, 1981, Southern California Edison indicated a scheduled implementation date for NUREG-0737, Item II.K.3.30 - "Revised Small Break LOCA Analytical Model" as March 31, 1982.

In a letter to you dated January 27, 1982, Southern California Edison indicated scheduled implementation dates for NUREG-0737, Items I.C.1 - "Procedure Guidelines" and II.K.2.17 - "Potential for Voiding in RCS During Transients," as "approximately April 1, 1982" and "no later than March 31, 1982" respectively.

A detailed review of implementation schedules for these items has revealed the dates indicated in the above letters were actually dates upon which Southern California Edison is expected to receive the required documentation from the Combustion Engineering Owners Group and therefore did not allow sufficient time for technical review and administrative processing by SCE.

Since each of these NUREG-0737 items involve only submittals of documented efforts by the Combustion Engineering Owners Group and will have no effect on the first cycle of SONGS 2 operation, SCE will submit the required documentation for NUREG items I.C.1, II.K.2.17 and II.K.3.30 for application to Docket Nos. 50-361 and 50-362 by approximately May 1, 1982.
