The NRC's letter of March 27, 1982, requested SCE to provide additional information relative to the existing capability of San Onofre Units 2 and 3 for rapid depressurization and decay heat removal without Power Operated Relief Valves (PORV's). The letter also indicated that SCE should provide a schedule for responding to the NRC's questions, and that if the responses to all the questions could not be provided at least one month prior to the expected date for operation of San Onofre Unit 2 at power levels above 5%, SCE should provide justification for full power operation of San Onofre Unit 2 in the interim until the issue is resolved.

In response to the March 27, 1982 NRC letter, SCE's letter of April 30, 1982 provided a justification for full power operation of San Onofre Units 2 and 3 in the interim until the issue of PORV's is resolved. The letter also indicated that the Combustion Engineering Owner's Group (CEOG) would sponsor preparation of generic responses relative to the fourteen (14) NRC questions and that SCE would inform the NRC as soon as the scope of work and schedule for preparation of responses were clearly defined.

Consistent with the above commitment, SCE is currently finalizing the scope of work for preparation of responses to the NRC questions and will transmit these responses to the NRC by June 30, 1983.
