Enclosed are sixty-three (63) copies of additional information concerning NUREG-0612, Control of Heavy Loads. This additional information provides responses to questions and comments discussed in a telephone conversation on June 17, 1982 between the NRC staff, EG&G, TERA and SCE concerning the July 7, 1981 SCE Heavy Loads submittal. Responses to the control of heavy loads information request for San Onofre Units 2 and 3 have been submitted to the NRC by letters dated July 7, 1981, April 30, 1982 and June 30, 1982. Evaluation of the Turbine Gantry Crane Side boom in accordance with Section 2.1 of Enclosure to the December 22, 1980 NRC letter is still underway and will be submitted by August 25, 1982.

Additionally, plant procedures for handling of heavy loads which were scheduled to be implemented by May 31, 1982 have not yet been implemented at San Onofre Units 2 and 3. This delay is due to our efforts to institute a crane and rigging control program in conjunction with San Onofre Unit 1. The efforts have resulted in an expansion of the scope of the task and training necessary to implement the lifting control program. The revised implementation schedule is as follows:

1. Implementation of crane operation procedures - October 1, 1982.

2. Completion of Operator Qualification and Training - May 1, 1983.

3. Implementation of the Rigging Control Program - May 1, 1983.

Until such time as the implementation of the above discussed actions is complete, the interim actions identified in the above referenced submittals continue to provide assurance that heavy loads are being handled safely at San Onofre Units 2 and 3. Following implementation of the corrective actions and the above discussed programs, we have determined that the load handling operations at San Onofre Units 2 and 3 will be in compliance with the criteria of NUREG-0612.
