Subject: Congressional Request for Information Concerning
Steam Generator Tube Integrity (Generic Letter 82-22)
San Onofre Nuclear Generating Station, Units 2 and 3
Docket Nos. 50-361 and 50-362

Your letter of October 26, 1982 to all Pressurized Water Reactor Licensees requests information regarding steam generator tube integrity. We understand this information is being requested in response to a request by Representative Edward J. Markey, Chairman of the Subcommittee on Oversight and Investigation.

In response to your above referenced letter, San Onofre Units 2 and 3 have only very recently received operating licenses with the full power license for Unit 2 received on September 7, 1982 and the low power license for Unit 3 received on November 15, 1982. Because of the recent receipt of these operating licenses we have not yet compiled an operating history to provide any meaningful response to your questions on steam generator tube integrity. Accordingly, we cannot provide a detailed response to the information request.
