By letter dated October 29, 1982, SCE informed you that we would be able to supply by January 1, 1983, a detailed cost/benefit analysis for proposed hardware modifications that will increase the reliability of the auxiliary feedwater motor driven pumps in the event of a break in the high energy line feeding the steam driven pump. Subsequently, the NRC staff requested additional information on the ability of the AFW pump motors to withstand a steam environment. This request was documented in SCE's letter of November 9, 1982. The purpose of this correspondence is to inform you that this schedule cannot be met and to provide you with a revised schedule.

Due to the unanticipated long lead time to prepare the additional information, SCE will not be able to supply the information by January 1, 1983. SCE currently anticipates the analyses and additional information requested will be transmitted to the NRC during the week of January 17, 1983.
