## SUBJECT: THE CATHOLIC UNIVERSITY OF AMERICA, REQUEST FOR ADDITIONAL INFORMATION CONCERNING FINANCIAL ASSURANCE DOCUMENTS, CONTROL NOS. 577961, 577962, AND 577963

Dear Mr. Conrad:

This is in reference to your letter of credit issued April 4, 2013, providing financial assurance for decommissioning for Nuclear Regulatory Commission License Nos. 08-02075-03, SUD-157, and SNM-164. In order to continue our review, we need the following additional information:

In Item 7 of our letter dated January 8, 2013, a request was made to revise the draft letter of credit with conditions to protect the licensee and the NRC from a possible default of the financial institution. In an effort to be more explicit, the NRC has certain requirements that a letter of credit must meet that can be found in the checklist on Page A-66 of NUREG-1757, Volume 3, Revision 1 (Enclosed). The item on the checklist is: "Notice of insolvency or violation of banking requirements." Page A-69 of the above NUREG (Enclosed) contains the model wording which is provided here:

"The bank shall give immediate notice to the applicant and NRC of any notice received or action filed alleging (1) the insolvency or bankruptcy of the financial institution or (2) any violation of regulatory requirements that could result in suspension or revocation of the bank's charter or license to do business. The financial institution also shall give immediate notice if the bank, for any reason, becomes unable to fulfill its obligation under the letter of credit.

Note: The financial institution may choose to amend the letter of credit rather than submit it in its entirety. The amendment would contain the above paragraph and the statement that all other terms and conditions of the letter of credit remain unchanged.
