Subject: NRC Inspection - San Onofre Unit 1

This refers to the inspection conducted by Mr. L. Miller of this office on November 3-26, 1980, of activities authorized by NRC License No. DPR-13, and to the discussion of our findings held by Mr. Miller with Mr. Brunet and other representatives of the Southern California Edison Company at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. In accordance with Section 2.790(d) of NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, documentation of findings of your facility security procedures are exempt from disclosure; therefore Enclosure 1 to this letter, your response to the item described in the enclosure and the Addendum to the inspection report will not be placed in the Public Document Room and will receive limited distribution.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. If this report contains any information that you believe to be proprietary, it is necessary that you submit a written application to this office, within 20 days of the date of this letter, requesting that such information be withheld from public disclosure. 
