SUBJECT: SUMMARY OF OCTOBER 30, 2013, PUBLIC MEETING ON
IMPLEMENTATION OF NEAR-TERM TASK FORCE
RECOMMENDATION 2.1, FLOODING HAZARD
REEVALUATIONS, RELATED TO THE FUKUSHIMA DAI-ICHI
NUCLEAR POWER PLANT ACCIDENT

On October 30, 2013, the Nuclear Regulatory Commission (NRC) staff held a public meeting¹ with stakeholders. The purpose of the meeting was to discuss the flooding hazard reevaluations that are being performed at all operating nuclear reactors. The flooding hazard reevaluations are being performed as part of Recommendation 2.1 from "Recommendations for enhancing Reactor Safety in the 21st Century," a report issued by the post-Fukushima Near-Term Task Force on July 12, 2011.² On March 12, 2012, the NRC issued a request for information pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Section 50.54(f) to implement this recommendation.³

The Nuclear Energy Institute (NEI) presented a revised version of Frequently Asked Questions (FAQ) 30,⁴ which incorporated NRC staff comments from the previous public meeting. The NRC staff indicated that they had no additional comments on the FAQ.
