In correspondence dated August 13, 2013, and November 12, 2013, you requested the release for unrestricted use of your Grand Blanc, Michigan location.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the location of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this location of use and it is suitable for unrestricted use.
