In Reference 4, PSEG provided a copy of the 1987 Annual Report, Artificial Island Ecological Studies, dated January 4, 1989 (ER Reference 2.4-222). During NRC review, the staff determined that the copy of ER Reference 2.4-222 submitted in Reference 4 was not a complete copy of the report.
