SUBJECT: LONG TERM SERVICE (LTS) SEISMIC CRITERIA AND METHODOLOGY - Rept SAN ONOFRE NUCLEAR GENERATING STATION, UNIT 1

By letter dated March 12, 1985, you submitted a report which describes the analysis methods and acceptance criteria that you propose to use to complete the seismic reevaluation for San Onofre Unit 1. Supporting information was provided in letters dated March 29, April 15, April 30, May 14, June 4, July 19, and August 2, 1985, as well as during meetings on February 12, February 27, April 1-2, April 30-May 1, June 10-11, and July 1-2, 1985.

The staff issued the results of a preliminary review of your proposal in a letter dated March 27, 1985, which identified issues requiring resolution prior to implementation of the plan. The enclosed safety evaluation report (SER) provides the results of the staff's review of your proposed LTS methodology and criteria. The issues addressed in the enclosed evaluation have been discussed extensively with your staff and consultants. While some of the alternative criteria and methods continue to be explored, we believe that this evaluation provides a sufficient basis for the Southern California Edison Company to complete implementation of the LTS plan.

The staff concludes that the proposed methods and criteria, as modified by and with the reservations and limitations noted in the staff's evaluation, provide a reasonable basis to complete the seismic reevaluation of San Onofre Unit 1 and to design any plant modifications necessary to ensure the plant's capability to withstand a 0.67g modified-Housner ground response spectrum earthquake. This evaluation also identifies those specific areas which require particular attention during your implementation of the LTS program. Mr. Kenneth P. Baskin

These issues are summarized in the conclusion of the SER and will be addressed as part of the staff's audit review of your implementation of the LTS program, which will include an independent confirmatory analysis of at least one piping subsystem.


