San Onofre Nuclear Generating Station Units 1, 2, and 3

Pursuant to Section 3.18.2, Action Statement B.1, of Appendix A, Technical Specifications, to Provisional Operating License No. DPR-13 for San Onofre Unit 1 and Section 3.12.2, Action Statement 'a' of Appendix A, Technical Specifications to Facility Operating License Nos. NPF-10 and NPF-15 for San Onofre Units 2 and 3, this submittal provides the required 30-day written Special Report for conditions identified during 1985 Annual Land Use Census.

The final Land Use Census results received by SCE on September 27, 1985 identifies locations which yield a calculated dose or dose commitment greater than the values currently being calculated in Specifications 4.6.3 and 4.11.2.3, for Units 1 and 2/3 respectively. Changes in calculated dose commitments are due to identification of a new occupational use of the land by State Park employees (life guards). This use, not reported to SCE in the preliminary Land Use Census report, affects the following locations:

1. San Onofre Surf Beach located in Sector P at 0.4 miles from Units 2/3 midpoint
2. San Onofre State Beach Campground located in Sector G at 0.8 miles from Units 2/3 midpoint
