Frank, I should have done my due diligence long ago, so first let me apologize for possibly putting you in an awkward situation

For the NRC to use the information we learn through our interactions with PJM, we will need to be able to make those interactions open to public perusal. For a public official, such as a mayor or an agent of a state or federal office, there is no presumption of privacy related to phone calls, personal visits, emails, etc. However, in dealing with a private person or entity, we need to make it clear to the person we want to put on the record that we will be speaking "on the record." PJM seems to be somewhere between a private entity and a public one, so I need to ask you: Do you consider our communications as public or private? If public, then we are good to go. However, if you consider our conversations private and not subject to citation in our EIS, we will need to identify a work-around. Typically that would entail finding a published document that says the same thing we want to rely upon in our work.

I will not make our previous communications public unless you are on board with that process, but from here forward, at least the rules are clear. Sorry for any unintentional inconvenience.
