SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

Dear Mr. Johanning:

This letter refers to your letter dated September 12, 2013, concerning your request to amend Nuclear Regulatory Commission (NRC) Exempt-Distribution Materials License No. 04-23994-01E for the purpose of changing the name from Science Application International Corporation (SAIC) to Leidos, Inc.

We currently do not have sufficient information to continue our review of your request. Although the information you provided indicates that only the name of your company has been changed, as opposed to a change of control, the NRC has a responsibility to determine the exact circumstances that led to the change. Please note that the Code of Federal Regulations, Title 10, Part 30, Section 30.34(b), states: "No license issued or granted pursuant to the regulations in this part and parts 31 through 36, and 39 nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing."

NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses: Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses," contains guidance concerning changes of control. This document is available on the NRC's web site at:

Specific information about changes of control is provided in Chapter 5 and Appendices C, D, and F. Please review this information to determine whether your request does or does not involve a change of control, and then respond accordingly.

Furthermore, based on your amendment request dated September 12, 2013, Registration Certificate NR-1373-D-101-E needs to be amended as well, since involves the Xpose Contraband Detector device listed in your license. In order to amend the Registration Certificate, please address the issues listed below. This information is required by 10 CFR 32.30 and described in the relevant guidance document NUREG-1556 Volume 3 titled "Applications for Sealed Source and Device Evaluation and Registration."

1. Please confirm the exact facility's name and location where the products are manufactured.
2. Specify the serial number of the last unit that was distributed by SAIC prior to the name change, and the number of completed units that were transferred to be distributed by Leidos, Inc. Please indicate how the records for these units will be kept.
3. If this is a change of ownership, please provide information discussing transfer of products, records custody, and servicing arrangements for products previously distributed.
4. Confirm that no changes were made to the product since its initial registration.
5. Confirm that there are no changes to previous commitments that have been made by SAIC. Specifically, please confirm that all the SAIC documents referenced in the Registration Certificate NR-1373-D101-E will be available to Leidos, Inc., and that Leidos, Inc. will comply with the commitments made in these documents.
6. Provide details regarding the Leidos, Inc. quality assurance program.

Please also provide a copy of your possession and use license from the State of California, and/or a copy of correspondence to indicate that the state has approved of your continued possession and use of byproduct material.

Any correspondence regarding your application should reference the control number specified above.

In accordance with 10 CFR 2.390 of NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in NRC's Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
