The sentence is removed because the staff is seeking Commission approval to move ahead to develop a defense-in-depth policy statement and will NOT begin serious work to develop "balance" until after the Commission SRM is received.

Following the accident at the Fukushima Dai-ichi nuclear plant in Japan, the NRC initiated actions to evaluate lessons learned and to implement appropriate changes in nuclear power plant designs and procedures. Initial recommendations were included in the Near Term Task Force (NTTF) report entitled "Recommendations for Enhancing Reactor Safety in the 21st Century." Several of the items (e.g., Recommendation 1 regarding improving the regulatory framework and Recommendation 2.1 on re-evaluating seismic and flooding hazards) include incorporation of risk-informed, performance-based approaches into NRC activities. The status and program plans for items identified for longer term evaluations were reported to the Commission in SECY 12-0095. A status update was provided in SECY-13-0020. [add link]

Risk Basis: Recommendation 1 is to develop a regulatory framework that appropriately balances defense-indepth and risk considerations. The exact nature of that balance is under development. The staff expects to provide options and recommendations to the Commission in December 2013. Recommendation 2.1 will use risk information as part of the determination of whether additional regulatory action is warranted.
