SUBJECT: RESPONSE TO NOVEMBER 4, 2013, SUBMITTAL OF ADDITIONAL INFORMATION REGARDING THE LICENSE AMENDMENT APPLICATION TO CONSTRUCT AND OPERATE THE LUDEMAN URANIUM *IN SITU* RECOVERY FACILITY, CONVERSE COUNTY, WYOMING

Dear Mr. Winter:

On January 15, 2013, the U.S. Nuclear Regulatory Commission (NRC) requested additional information regarding Uranium One Americas Inc.'s (Uranium One's) amendment application to SUA-1341 to construct and operate a uranium in situ recovery (ISR) facility at its Ludeman site in Converse County, Wyoming (ML12352A034). Uranium One responded to NRC's request for additional information (RAI) on June 24, 2013 (ML13191A248). NRC's acceptance review of Uranium One's RAI response determined that Uranium One did not adequately respond to Technical RAIs 1, 3, 6, 7, 8, 14, 16, 24, 28, 30, 34, 36, 39, 41, 42, 44, 57, 58, 59 and Environmental RAIs WR-1, WR-2. As a result, on August 8, 2013, NRC suspended the technical and environmental reviews of Uranium One's license amendment application for the Ludeman facility (ML13200A040).

By letter dated November 4, 2013 (ML13324A599), Uranium One submitted information for Technical RAIs 3, 6, 7, 8, 14, 16, 24, 28, 30, 34, 36, 41, 42, 44, 57, 59 and Environmental RAIs WR-1, WR-2. Uranium One has committed to provide the requested information for RAIs 1, 39 and 58 following clarifying discussions with NRC staff. With regard to RAI 1, the NRC's regulations at 10 CFR 40.44 specify that licenses will be amended at the requesting the licensee. To satisfy the requirements of 10 CFR 40.44, the corporate entity requesting the license amendment to add the Ludeman facility as a satellite facility must be the same as the corporate entity that owns and operates the Ludeman facility as indicated on the NRC license for the facility. The license amendment request should include a revised corporate organization chart and discussion. In addition, Uranium One should provide sufficient legal documentation to demonstrate that Uranium One owns, or has the rights to, the land occupied by the proposed Ludeman facility.
