On November 5, 2013, representatives of NextEra Energy Duane Arnold, LLC, met with NRC personnel in the Region III office located in Lisle, Illinois, at a Regulatory Conference to discuss the safety significance of the finding and apparent violation identified in NRC Inspection Report Number 05000331/2013010. The finding involves failure of a lubricating oil gasket on one of the standby diesel generators. The conference was held at the request of NextEra Energy Duane Arnold, LLC.

The licensee presented a summary of their risk evaluation, the causes for the apparent violation, and their corrective actions.
