Description of Change:

This amendment incorporates the previously submitted Change Notice 39. This amendment also addresses the following program enhancements and clarifications:

The organizational structure figure was separated into multiple charts for ease of use and clarity. SCE also wishes to inform the NRC that the organizational structure as stated in Subsection 17.2-1 is as of June 15, 1993. SCE is in the process of reorganization and will inform the NRC of the completed change in a Change Notice.

The responsibilities for the implementation of the environmental program was transferred to the Site from a corporate organization.

The process for the control of purchased material and equipment remains unchanged; however, the description in Subsection 17.2-7 was clarified to be more consistent with current industry terminology and ANSI N45.2.13.

The approval authority for dispositions of nonconformance reports was clarified to be consistent with engineering responsibilities between the design organization and the station.

Table 17.2-2 was updated to reflect organizational responsibilities and titles.


Table 17.2-3 was clarified address the generic follow up of corrective actions, not just the use of audits to reexamine issues and to address minor editorial changes.


