SUBJECT: REVISIONS 5.4 AND 5.5 TO THE SAN ONOFRE NUCLEAR GENERATING
STATION (SONGS) EMERGENCY PLAN

This letter refers to your August 2 and 27, 1993, letters which forwarded Revisions 5.4 and 5.5, respectively, to the SONGS Emergency Plan. The revisions were sent to us for review under the provisions of 10 CFR 50.54(q).

We have completed our review of the emergency plan changes. We concluded that Revisions 5.4 and 5.5 continued to meet the standards in 10 CFR 50.47(b) and the requirements of Appendix E to Part 50. I understand that in response to some of our comments, Mr. C. Anderson of your staff agreed to make two minor changes in the next revision to the SONGS Emergency Plan. This agreement was reached during a September 9, 1993, conversation with Ms. G. Good of my staff.
