The Commission has issued the enclosed Amendment No. 53 to Provisional Operating License No. DPR-13 for the San Onofre Nuclear Generating Station Unjt No. 1. This amendment consists of changes to the Technical Specifications in partial response to your request (Proposed Change No. 94), dated October 15, 1980.

The amendment modifies the Appendix B (Environmental) Technical Specifications to delete Sections 3.1 "Nonradiological Surveillance", 4.1 "Chlorine", 4.2 "Fish Impingement" and 4.3 "Entrainment" which contain monitoring programs for the protection of the aquatic environment. The NRC will rely on the requirements of the effective National Pollutant Discharge Elimination Systems (NPDES) Permit issued by the State of California for the protection of the aquatic environment.

The remainder of your requests of February 8, and October 15, 1980, will be incorporated into a total revision of your Appendix B (Environmental) Technical Specifications. This revision will move the nonradiological requirements to an Environmental Protection Plan (EPP) which will be Part II of Appendix B. The EPP will extend our reliance on the NPDES Permit for all aquatic controls and will specify reporting requirements to assure that the NRB remains aware of potential impacts to this segment of the environment.

We have determined that this amendment is a ministerial action required as a matter of law and, therefore, an environmental impact statement or negative declaration and an environmental impact appraisal need not be prepared in connection with the issuance of this amendment.
