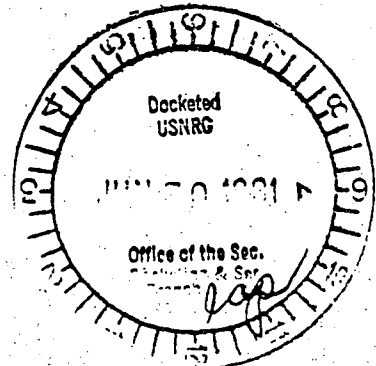
Dear Mr. Hendrie:

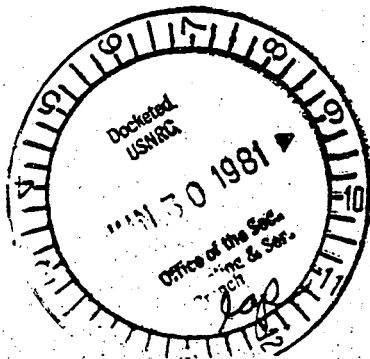
