Dear Mr. Kilkuskie,

On October 31, 2013, an inspector from the U.S. Nuclear Regulatory Commission (NRC) conducted a routine inspection at your facility in Kalamazoo, Michigan, with continued in-office review through November 4, 2013. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. The in-office review included a review of records of the radiation protection program. Mr. Craffey of my staff contacted you by telephone on November 12, 2013, to discuss the inspection findings.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that one minor violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html. The violation, identified by the inspector, concerned MTEC's failure to notify the NRC in writing within 60 days that no principal activities under the license had been conducted for a period of 24 months, as required by Title 10 of the Code of Federal Regulations (CFR) Part 30.36(d)(3).

Licensees are required to report such occurrences so that the NRC can take prompt and appropriate regulatory action to ensure that any residual radioactivity is adequately addressed. The NRC takes failure to do so seriously, as it impedes the NRC's ability to perform its regulatory process. However, we have evaluated this violation and determined that the lack of principal activities had minimal radiological or programmatic significance. Therefore, we have determined that the significance of the violation is minor.
