Dear Secretary,

As a resident of Washington State, I am affected both by the constant question of how to further clean up Hanford and the question of how Japan's recent reactor problems will impact the Pacific fisheries. Please move beyond this idea of "confidence" and make the moratorium on new leasing and renewal of previous leases of nuclear power facilities in the U.S. permanent.

We quite literally have no place for the creation of more nuclear waste, even if it is only from power plants and not from weapons production. To this day, there is no clear evidence that there is any way to safely store nuclear waste indefinitely. Obviously, given the nature of these waste products, storing them for an indefinite period of time is the only real solution. Please do not allow this moratorium to be a temporary stop gap measure when other types of energy development are needed and wanted by the public.

Nuclear energy is not carbon neutral given the amount of concrete and other resources needed to build, repair, or maintain these facilities. Their cost in dollars and to the environment and to future generations is too high; without adequate benefit to justify continuing their use.
