# NOTIFICATION OF THE NRC STAFF'S PROPOSAL TO DISPOSITION RECOMMENDATION 1 OF THE NEAR-TERM TASK FORCE REPORT (FSME-13-127)

**Purpose:** To provide notification of: 1) the U.S. Nuclear Regulatory Commission (NRC) staff's proposed regulatory framework improvement activities to disposition Recommendation 1 of the Near-Term Task Force Report; and 2) a public Commission meeting that will be held on this topic on Friday, January 10, 2014.

**Background:** Following the accident at the Fukushima Dai-ichi nuclear power plant in Japan in March 2011, NRC assembled the Near-Term Task Force, which issued a report with 12 recommendations ("Recommendations for Enhancing Reactor Safety in the 21<sup>st</sup> Century," <a href="http://pbadupws.nrc.gov/docs/ML1118/ML111861807.pdf">http://pbadupws.nrc.gov/docs/ML1118/ML111861807.pdf</a>). Recommendation 1 was for the NRC to establish a "logical, systematic, and coherent regulatory framework for adequate protection that appropriately balances defense-in-depth and risk considerations." The NRC staff has evaluated Recommendation 1 and submitted a proposal to the Commission with options and a recommendation for its disposition (SECY-13-0132, dated December 6, 2013). A public Commission meeting to discuss the staff's proposal will be held on Friday, January 10, 2014.
