
Dear Mr. Seeley:

In response to your request dated 18 September 2013, mail control number 581698, a review of all NRMPs was conducted in October 2013 to evaluate the possession limits of unsealed by-product, source, and special nuclear materials. This review was performed to ensure the accuracy of the allowable limits, and to ensure the proper form is provided. This review is expected to result in the need to modify the appropriate NRMPs, and a need to modify the Navy's 2012 certification of financial assurance required by Title 10, Code of Federal Regulations, Parts 30, 40, and 70.

Enclosure (1) provides a Plan of Action and Milestones (POA&M) for amending NRMPs and providing certification of financial assurance, and decommissioning funding plans for appropriate activities under the Navy's MML.
