Entergy Nuclear Operations, Inc. (ENO), operates the James A. FitzPatrick (JAF) Nuclear Power Plant Independent Spent Fuel Storage Installation (ISFSI) in accordance with the general license provisions of 10 CFR 72.210. The conditions of 10 CFR 72.212(b)(2) include the registration of a spent fuel cask within 30 days of using a cask for storage of spent nuclear fuel.
