**Purpose**

The purpose of this letter is to provide a response to the U.S. Nuclear Regulatory Commission's (NRC) request for additional information (RAI) for review.

**Background**

On February 27, 2013 (Reference 1), American Centrifuge Operating, LLC (ACO) submitted changed pages to the Security Program for the American Centrifuge Plant (NR-3605-0004) in accordance with 10 *Code of Federal Regulations* (CFR) 95.19(a)(2) and (b) to satisfy the associated periodic reporting requirement. On November 29, 2013 (Reference 2), the NRC issued a RAI regarding the applicability of certain change provisions to Classified Distributive Information Network plans.

**Discussion**
