**Replenishment of Potassium Iodide (KI) Tablets**

On December 12, 2013, the NRC entered into an indefinite delivery/indefinite quantity type, Inter-Agency Agreement with fixed unit prices with the Department of Health and Human Services, Supply Service Center of Perry Point, MD. This agreement is for the procurement and delivery of 65mg KI tablets necessary to replenish expiring stores in states with areas of population within a 10 mile radius of commercial nuclear reactors (as per Staff Requirements Memorandum – SECY-09-0041 – “Recommendation For Future Replenishment of Potassium Iodide”). The period of performance is from December 13, 2013, to December 12, 2018, inclusive of one 5-year base period. The total estimated ceiling cost is \$6,655,084.37.

**Automated Acquisition Management System**

On December 18, 2013, non-competitive delivery order (NRC-HQ-13-F-10-0001) was awarded under General Service Administration contract number GS35F5370H to Distributed Solutions, Inc. of Reston, VA. The award was for The Automated Acquisition Management System license subscriptions. The period of performance is from December 1, 2013 to May 31, 2014, inclusive of a 3-month base period and one 3-month option period. The total value of the award is \$227,456.50, inclusive of all options.

**Nuclear Energy Institute's Tabletop Exercises**

On December 18-19, 2013, the staff, in support of Risk Prioritization Initiative and Cumulative Effects of Regulation, observed the Nuclear Energy Institute's (NEI) "tabletop exercises" on prioritization. NEI used preliminary guidance from the draft NEI Guidance which they had transmitted to NRC on October 1, 2013 (ADAMS No. ML13276A147). The tabletop exercises consisted of five generic topics to test the risk-informed prioritization process. Staff provided feedback and insights on the proposed process. Following the meeting, NEI indicated that it would use the NRC staff insights to revise the guidance in support of a set of plant-specific tabletop exercises planned for the February 2014 timeframe. It is expected that the outcome of these tabletop exercises would inform both the staff in its development of a notation vote paper and NEI in its effort to assemble final guidance to support potential piloting activities in the future.
